GUIDELINES FOR USERS OF PRIVATELY OWNED RIDE-ON GOLF VEHICLES

1. Privately owned ride-on golf vehicles must comply with club policies as directed.
2. All persons must have attained a minimum age of 16 years & have a valid up to date drivers licence before they are permitted to drive privately owned club-registered ride-on golf vehicles on the golf course.

3. No ride-on golf vehicle shall be driven within twenty (20) metres of any green or ten (10) metres of any tee unless the vehicle is on a manmade path or track.
4. Ride-on golf vehicles shall **at all times use paths and tracks** wherever they are provided; and
5. Ride-on golf vehicles shall be shared as much as possible to minimise the number of vehicles on the course – *a maximum of two golf carts per group is encouraged*. This is considered by the Board to be a matter of courtesy, course etiquette & good long-term management of the course.
6. Owners are encouraged to park their ride-on golf vehicles in the marked areas adjacent the Pro-shop & parking bays leading toward the 10th tee. Ride-on golf vehicles are not permitted to be parked at the entrances to the clubhouse or in the car park.
7. Ride-on golf vehicles shall enter the course as follows so as to minimise damage to the course and so as to facilitate golf play with minimal interference:
 - ✓ From private residences then proceed to club on dedicated carts paths or rough.
 - ✓ From lane way adjacent 3rd tee then proceed along 2nd rough to cart paths leading to club.
 - ✓ Access road from Tura Beach drive then down access road to greenkeepers shed turning up to club at practice range then up behind 9th green eliminating 8th fairway.
 - ✓ Behind 13th, 16th & 18th greens along cart paths.
8. Following rainfall, please contact the website or Golf Professional Shop on 6495 9068 for conditions of play & specific instructions including that carts must remain on dedicated cart paths
9. Users shall obey all relevant instructions provided by board directives, staff, signs and notices.
10. Owners of ride-on golf vehicles using the golf course should have private insurance for property and public liability.
11. Owners of ride on golf vehicles must display registration label and cart rules label prominently at all times

PENALTIES: All non-compliance incidents will be reviewed by the board which may result in rescinding of cart registration & privileges & or suspension of membership.
